The inorganic composition of CAFCO BLAZE-SHIELD II HS, combined with its UL “investigated for exterior use” classification, allows CAFCO BLAZE-SHIELD II HS to withstand exposure to weather conditions during the construction cycle without compromising the fire resistive rating.
